### EXHIBITS

Exhibits will be held in the Bon Secour and Preconvene foyer of the Renaissance Riverview Plaza Hotel in downtown Mobile, AL. You have the option of purchasing space for a table-top exhibit or a free-standing booth. Exhibits will be displayed for the duration of the technical sessions. Conference breaks will also be held in the foyer to ensure the most traffic to your booth.

**Exhibit Hours:** Wednesday and Thursday, Nov. 12-13: 8:00am – 5:30pm. High traffic times will be during the breaks in between sessions\*:

*\*The Opening Reception on Tuesday, Nov. 11 will be held in the Jubilee Suite, adjacent to the exhibits area. We recommend that the booths be set up in time for the reception because people will be wandering around the area during this time. We might even have to set up food and beverage in the exhibits area if we need overflow room from the Jubilee Suite. Other high traffic times will be immediately before and after the technical sessions.*

Exhibit space consists of one skirted table 6 feet long by 2 feet deep by 2.5 feet high, 2 chairs and a trashcan. Power and telephone connections are not included in the exhibit fee and must be arranged by exhibitors with the hotel directly. There will be no pipe & drape partitions. The price of the booth does NOT include a conference registration. All exhibitors must be registered for the conference.
