






CIVIL WORKS PROGRAM/BUDGET TIMELINE



NOTE: PY = CFY + 2




FY 2023 CIVIL WORKS REGULAR PROGRAM SUMMARY








CONSTRUCTION FUNDING TRENDS



COST ENGINEERING POLICY CLARIFICATION AND GUIDANCE

□ Mr. Pete Perez, SES, Chief Engineering and Construction, HQUSACE has issued following policy guidance memorandums in the past few years that affects Civil Works and MILCON programs across the enterprise:

- Memorandum for Cost Engineering Community of Practice Development of Budget Estimates and Construction Duration Schedules for MILCON to reflect Current Market Conditions and Inflation – 21 April 2022
 - Addresses the inclusion of true inflation into the budget estimates above the OMB mandated rates. The guidance provides clear direction to cost engineers on how to calculate and include this inflation in the baseline estimate and risk-based project contingencies.
- Memorandum for Cost Engineering Community of Practice (CoP), USACE Inflation Risk Assessment and Inclusion in Current and Future Year Project/ Construction Cost Estimates in Civil Works – 7 April 2023
 - Addresses project cost estimate update requirement per ER1110-2-1302 and the use of Civil Works Construction Cost Index System (CWCCIS).
 - Makes the distinction between Regular Civil Works Program and Supplemental Programs and challenges on how to develop and include inflation factors.
- Memorandum for District Commanders, Deputy District Engineers, Engineering Chiefs and Cost Engineering Community of Practice (CoP) – Guidance on Cost Engineering Products update for Civil Works Projects in accordance with Engineering Regulation 1110-2-1302 – Civil Works Cost Engineering – 5 June 2023
 - Addresses the importance of accurate project scope development as the key driver in develop accurate project cost estimates.
 - Provides clarification that all Authorized (active) and Authorized but Unconstructed (ABU) must meet the cost engineering requirements when requesting funds.
 - Provides minimum requirements on Geotechnical Data, Hydrology and Hydraulics requirements and Survey requirements early on during the project study phase and/or PED phase as the basis of development of project costs.
 - Provides framework of communication at the district level within several office, i.e., Programs & Engineering
 - Provides clarification of identifying the DESIGN MATURITY as the key factor in determining the cost estimate classification.
 - Provides a "Matrix for Additional Certification" requirements based on the project phase.
