- Stage III (dam equip rehab) awarded in FY 08. Const. spring '09, completion Aug '10 Issue:

Stage III-B, Dam Concrete Repairs design pending funding.

### Lockport Upper Pool Maj. Rehab. (Lockport Approach Dike), Illinois Waterway, IL



Project Cost: \$137,000,000 Remaining Balance: \$116,382,000 FY 09 Projected Allocation: \$28,600,000

- Complete 4,300 ft. of cut-off wall in approach dike.
- Repair access road
- Award Contract for Canal wall (Sep 09)



# Inner Harbor Navigation Canal Lock, LA



- **Project Cost:** \$1,300,000,000
- Remaining Balance: \$1,200,000,000

### FY 09 Activities

- Finalize Supplemental Environmental Impact Statement (SEIS)
- Present SEIS to federal Courts for a ruling
- Lock Structure Design
- Award contracts for demolition and site preparation.

#### Milestones:

•Present SEIS to Federal Courts (June 09)

#### Issue:

•While cost has increased, a recent detailed cost estimate indicates it is not expected to exceed the authorized limit.
