Members of my staff recently met with several representatives of the Corps to clarify appropriate locations for detailed investigation. Two adjoining areas were delineated. Shown on the enclosed map, one is bounded by a pipeline canal to the north and Bayou Yscloskey to the south and the other immediately adjacent to the southeast is bounded by Doulluts Canal. These small areas were selected because of their rapid erosion and their potential for restoration. It was determined that together these parcels are of an appropriate scale to satisfy mitigation requirements without undue financial burden.
