# Chickamauga Lock Replacement BLUF

#### Bottom Line Up Front

- Lock Excavation contract is progressing. Remaining contract options will be exercised by 31 July 2017. Expiration dates for the options were extended from 31 May at no additional cost.
- Lock Chamber contract package was advertised on 19 June 2017, with a bid opening scheduled for 23 Aug 2017. Anticipate awarding the contract in Sept 2017. Scope includes concrete placements and installing previously fabricated steel components.
- District is developing a Post Authorization Change Report (PACR) due to certified total project cost estimate of \$755M exceeding the current authorized 902 limit of \$482M.




