

## Major Project Features

- Similar work at Montgomery, Dashields, & Emsworth
  - Demolish the existing 56' x 360' Auxiliary Chamber
  - Construct a new 110' x 600' Main Chamber
  - Modifications to dams
- Financial
  - 902 Limit: \$3.87 Billion
  - Fully Funded Estimate at Completion<sup>1</sup>: \$1.81 Billion

## **Upper Ohio - Discussion**

- Seeking construction "new start" as soon as possible (FY 2021)
  - FY20 is likely the last year of GI-PED funding
  - Funding from the Construction General account is likely to be more efficient than GI-PED
  - Positioned to advertise first construction contract in 2021
  - Position to award the Montgomery Locks contract in FY 2023 funding dependent
- Economic re-analysis completed in February 2020 (BCRs)
  - 1.1 to 1 @ 7%
  - 2.4 to 1 @ 2.75%
- Risks
  - $\circ~$  Facility failure occurs while waiting for funds
  - $\circ~$  Facility failure occurs while under construction
  - $\circ~$  Other IWTF priorities
