KENTUCKY LOCK OVERVIEW OF SCOPE



Authorization:

The Water Resources Development Act (WRDA) of 1996 (P.L 104-303) & Project reauthorized in WRDA 2020 (P.L. 116-260)

Purpose/Description:

Construction of a new 110' x 1200' lock addition at Kentucky Lock. The existing navigation lock is too small to meet current and future traffic demands without significant delays. Kentucky Lock's delays are among the highest in the country. In the last three years, the average delay for vessels transiting the lock has been over 10 hours. The addition of a new larger lock will essentially eliminate these delays well into the future.

Ongoing/Remaining Work:

- Current Contracts:
 - DS Excavation (\$54.8M) Awarded 26 Sep 2018 to Heeter Construction
 - Contract Completion is 07 JUN 2022
 - DS Monoliths (\$167M(\$380M)) Awarded 30 Sep 2021 to Thalle Construction
 - Contract Completion is 19 MAY 2027



FY22 – DOWNSTREAM EXCAVATION PROGRESS








FY22 Progress Included:

DOWNSTREAM LOCK MONOLITH- PLAN








KYL SCHEDULE - ONGOING & REMAINING WORK



Kentucky Lock funds to date

- The Downstream Lock Monoliths (DSLM) contract base (\$167M) + 8 options (\$213M) for a total contract \$380M was award 30 Sept. 2021. Market Conditions extended the Period of Performance (54 to 67 months). Contract award was \$158M above the FY20 estimate.
- IIJA funding (\$465M) enables award of all 8 options on the Downstream monolith contract and award of the Approach Wall base contract.

Funding Required

- Additional funding will be required for the options on the approach wall contract and Electrical and Mechanical Features, Lock Operations Buildings and Bridges, and Site Restoration.
- Cost estimates for remaining work are being revised to account for the changed market conditions since the FY20 estimate update
- The FY22 Cost Estimate will be Certified and provided in May 2022



KENTUCKY LOCK ISSUES AND CHALLENGES



Top Issue: The Downstream Lock Monoliths contract (major remaining work on lock chamber) grew from 54 months to 67 months, moving the operational date. Due to market conditions the procurement came in at \$158M above the FY20 estimate.

<u>Issue:</u> Schedule - Earliest completion of the Lock Monolith contract is mid-2027. The Corps is working to optimize schedule and scope, mitigating additional funding requirements and determining most aggressive on-line date.

<u>Issue:</u> Funding - The Corps expects to complete the certified Total Project Cost Estimate update in May 2022.

Path Forward:

• The Corps team is working to integrate remaining scope and schedule optimization to support the earliest online date and efficient funding.
